1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The Institution makes efforts in effective implementation of curriculum. Being affiliated to Shaheed Mahendra Karma University, Jagdalpur. The Syllabi and over all guidelines are laid down by the university. The syllabi are reviewed by the members of Boards of Studies yearly. Most of the senior teachers of this college are the members of Board of Studies of different subjects. The academic calendar is providing by the Higher Education Department of the Government of Chhattisgarh. The institution currently runs courses in Arts, Science and Commerce. There are 07 PG and 17 UG courses offered in our institution. At times various value added courses are organized to sensitize students towards gender, environment, human values, and professional ethics issues for a holistic development of students. Students are given assignments and projects to encourage the experimental learning. Curriculum redesigning and revision is done based on the feedback from stakeholders (Students, Teachers, Parents, & Alumni) via Google forms and efforts are made to identify the drawbacks and enhance the learning effectiveness.

Teaching-learning and Evaluation

The most important thing in teaching learning process of any education institute is the ability of its teachers to create enthusiasm, ignite passion and generate curiosity among the students. The college admits students from all sections of society. College efforts have increased the student enrollment in last 5 years from 859 in 2017-18 to 1518 in 2021-22. The college is in tribal area hence seats are reserved under various categories; the percentage of seats filled against reserved categories has also increased. The students and full time teacher ratio is 75.9:1. Total Number of Permanent Teachers in the college is 20. Amongst them 07 are Ph.D. holders. To compensate vacant posts, appointment of teachers as part time teacher has been made by jan Bhagidari samiti. Besides this, teachers are appointed by C.G. Govt, on contractual basis. Teachers prepare their teaching plans which are implemented and reviewed by the respective Head of the Departments and the Principal. The lecture method of teaching is supplemented by workshop, seminars and symposia, Field visits, survey and excursions are organized for the students. The college has well equipped science laboratories, computer labs and seminar hall to facilitate participative and experimental learning experiences. The ICT enabled class rooms Wi-Fi campus supports the teaching learning process and improves the quality of learning. There were 19 regular full time teachers in 2021-22, 90% full time teachers are with Ph. D. and NET/SET qualification, enriching the teaching with experienced and young teaching staff providing quality education to the students of this tribal area. For evaluation process the rules and regulation of the university is followed. The pass percentage of students during last five years has increased from 91% in 2017-18 to 99% in 2021-22.

Research, Innovations and Extension

The college encourages its teachers to submit research projects, Research proposals to UGC and other authorities for research activities. The institution has a research centre in History department and Madam Dr. Shikha Sarkar is also recognized research guide of University. The teaching staffs are taking active participation in National/International Seminar/Webinar. They are writing original and authentic research papers in UGC care journals. Book Chapters are also written by the teaching staff at times. NSS/NCC takes initiatives for extension and outreach programmes conducted by the institution. There are 03 functional MOU's for academic collaborations of our institution. College has received District Green Champion Award from Ministry of Education GOI. The students participate In Extension activities like Community Development, Health and Hygiene awareness, AIDS awareness social works, Blood Donation Camps, Environment awareness, tree plantation etc. through NSS, NCC, Red Cross and Eco Club. Students and teachers are also encouraged to participate in such extension programmes. Red Cross units are working continuously in the college.

Infrastructure and Learning Resources

The institute has a separate auditorium to organize curricular/cultural activities, conferences and workshops. Separate boys and girls hostels are available and controlled by the Govt. of Chhattisgarh. It provides accommodation to the students coming from nearby socially and economically deprived area.. The college has its own infrastructure facilities to keep pace with the expansion in its academic and research programme. Institution has 23 well ventilated and spacious classrooms to aid better teaching learning practices. Laboratories: Institution has well equipped 08 science laboratories and 01 Psychology laboratory. Computer labs: There are 02 computer labs with 39 computers, and well established LAN facility. There is 01 well ventilated and spacious seminar hall. There are 02 air conditioned smart classes, well connected with LAN and Wi-Fi, and projectors installed. ICT Facilities: Campus is Wi-Fi enabled; there are 56 working computers, Laptops, Projectors, Camera. Staff Room: There is one common air conditioned staff room, with LCD and Wi-Fi facilities. There is 07 departmental libraries in all PG departments and 01 main spacious, well ventilated library equipped with 26603 of books, with registration in INFLIBNET. There are 2 network connections, BSNL broadband speed varies from 10MBPS to 30 MBPS.

Student Support and Progression

The college has strong student support system to achieve academic excellence by providing financial support in the form of Government and Industrial Scholarships. 1045 students have received financial support from scholarships. Government Scholarship of Rs. 25, 09,085 received by 632 students and Industrial Scholarship by NMDC and Sitaram Jindal of Rs. 20, 45,600, benefited 413 students. Capacity building and skill enhancement initiatives such as language and communication skills and ICT/ computing skills have been provided. Placement cell of the college has guided students for career counseling and competitive exams from workshops and seminar organized by the institute. 95 students are pursuing higher studies after completing their programme in 2021-22.

Governance, Leadership and Management

College adopts a participatory management in academic and administrative activities and views and suggestions from stakeholders, Jan-Bhagidari Samiti members are considered for college activities. The faculty members are involved in decision making and policy formulation of the college. Rule and regulations of the respective

Student Admission and Examination (Internal marks and practical marks) are done online with the support of the university. The institution provides various welfare schemes of government in the form of leaves and various financial benefits. Staff takes part in faculty development programmes and different trainings. Finance committee meets regularly to prepare strategies for resource mobilization and utilization. IQAC monitors and reviews the teaching learning process. It also encourages the faculty members to adopt new and innovative teaching methods using ICT Tools.

Psychological Counselling for students

- Govt. Danteshwari PG College is a affiliated college of Shaheed Mahendra Karma University, Jagdalpur Bastar (C.G.). The Institution is a leading college in Tribal area of South Bastar region. Students from remote areas of Sukma, Bijapur, and Dantewada get admission in our college.
- These remote tribal area like Konta and Chindgarh block of Sukma and Bhopalptnam and Usoor block of Bijapur district face major problem of inaccessibility, lack of quality and quantity of the human resource, lack of transport and communication facilities, LWE activities in interior part of these districts.
- The students from these problematic areas of following districts go through various Psychological problems and are introvert to talk about their problem, these problems were more prominent during the pandemic years.

- Having Psychology department in the college, institution took decision to take counselling of such students from LWE affected areas, backward areas about their study related and other psychological problems. Major problem of such students are frustration, aggression, anxiety, depression, stress and lack of empathy.
- Department of Psychology was opened in the college in 2009-2010, but no regular teaching staff was appointed, in **2020-21 Dr. Manoj Kumar Rao** joined the institution as HOD of the Psychology Department, then in **2021-22 joined Dr. Dinesh Kumar Lahari** and both observed the problems of students and started the counselling of students.
- During the pandemic second lockdown also, the department was giving telephonic counselling to the needy.
- This departmental counselling was in association with the **Psychology Department of the District Hospital Dantewada** converted as **"Mental Health Counselling Centre"** in 2022-23 and opened not only for students but also all those who need counselling.
